Membership Options:

Membership is based on the calendar year, January 1 2012 – December 31 2012. Memberships are not prorated and are renewable each January. Options are to join AAVAC, AAV, or both AAV and AAVAC.

AAVAC: Membership of the Australasian Committee only. This is open to anyone who fits into AAV membership categories active, graduate student, resident, retired, or student. Includes membership of AAVAC Online Discussion Group.

AAV: **The AAVAC treasurer will accept payment of your 2012 AAV membership if paid by before January 30 2012. All Australasian committee members AAV dues are then paid in a lump sum to the AAV central office.**

Categories are:

1. Active: A graduate of a school of veterinary medicine accredited in the country of issue.
2. Graduate Student, Resident, Retired: Same as active above.
 - a. Full time postgraduate students and residents must submit a letter from advisor stating they are enrolled in a recognised program in the country in which their degree was issued.
 - b. Retired active member maintaining membership for 15 consecutive years immediately preceding their retirement.
3. Student: Enrolled in a professional veterinary curriculum. Copy of current student ID must accompany application
